WAIVER OF LIABILITY: RELEASE OF CLAIMS, INDEMNITY AGREEMENT AND COVENANT NOT TO SUE

I acknowledge and agree that the use of and participation in any Kids' Nite Out Across America (from this point referred to as KNOAA) program, no matter the facility location, has inherent risks of injury and loss, and I expressly and voluntarily assume those risks which my child (or child in my care) may sustain as a result of participating in any activities connected with or associated with such a program. I have full knowledge of the nature and extent of all risks associated with sports activities and inflatable jumping apparatuses, including but not limited to: All manner or injury resulting from falling off any of the inflatables and hitting equipment (whether permanently or temporarily in place), other persons, or the floor. I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the facility or participation in the various activities offered and that the above list in no way limits the extent or reach of this release and covenant not to sue. I hereby certify that my child (or child in my care) is in good health and has no physical limitations which would preclude safe participation in the KNOAA program. I give permission for photographs to be taken of my child (or child in my care) at any KNOAA program to be used for promotional purposes.

In consideration of my child's (or child in my care) participation at any KNOAA program, I the undersigned user (or parent/authorized adult of user), agree to release, indemnify, and hold harmless, on behalf of myself, my heirs, representatives, executors, administrators, and assigns hereby do release, indemnify, and hold harmless KNOAA, and the individual KNOAA owner/operator, its officers, agents and employees from any cause of action, claims, or demands of any nature whatsoever, including but not limited to, a claim of negligence, which I, my heirs, representatives, executors, administrator,s and assigns may now have, or have in the future against KNOAA, and the individual KNOAA owner/operator, its officers, agents and employees, on account of personal injury, property damage, death, or accident of any kind, arising out of or in any way related to my child's (or child in my care) use and participation in any KNOAA program, whether that use or participation is supervised, however the injury or damage is caused, including, but not limited to the negligence of KNOAA, its officers, agents and employees. I also understand that KNOAA is not a child care provider, but is a drop-in program, and that KNOAA is not responsible for my child (or child in my care) while attending the KNOAA program, and that my child (or child in my care) has the freedom to leave the program at any time without restraint.

I understand that the terms of this agreement are legally binding and that it may not be modified orally. I certify that I am signing this agreement as the parent or authorized adult of the participant and that it is binding upon me, my successors, heirs, representatives, assigns and executors. I understand that by signing this agreement, I give up my right to bring a court action to recover compensation or obtain any other remedy for any injury, damage to property, or death of my child (or child in my care) however caused, arising out of their participation in any activities that take place during any KNOAA program, now or at any time in the future. I hereby certify that I have read, understand and agree to the contents of this agreement and sign the same voluntarily and of my own free will.

Youth Rules for Kids' Nite Out Across America®



Youth attending MUST read and sign this portion of membership card.

1. All youth must read and agree to all rules of the program. Parents should also read these rules. Youth must read and sign card. There are no exceptions!
2. Any youth who does not follow the rules will be suspended or expelled from the Kids' Nite Out Across America® program. All privileges of the youth will be terminated without refund.
3. Rules include, but are not limited to: NO smoking, NO drugs, NO alcohol, NO inappropriate clothing, NO fighting, NO gum, NO profanity, NO dirty dancing, NO black soles shoes in the gym or danceroom, NO food or drink outside of designated areas. Some of these rules are punishable by fines and/or imprisonment. A police officer is always on duty.
4. Kids' Nite Out Across America® and the facility are not responsible for lost or stolen items. Lockers are provided at most locations, but you may need to bring your own lock.
5. Once you leave the facility and the Kids' Nite Out Across America® program you may not return.
